The Österreichische Detektiv-Verband (ÖDV) has been founded in 1949 and is the largest and longest established voluntary organisation representing professional Investigators in Austria.

Austrian investigators are licensed and entitled to conduct the following:

- 1. Information about private matters
- 2. Inquiries on criminal offences
- 3. Obtaining evidence for judicial or administrative proceedings



4. Investigate missing or hiding people, authors, initiators or senders of anonymous letters, initiators or circulators of defamations, suspicions or insults

- 5. Monitoring and examination of employees loyalty
- 6. Customer surveillance in business premises
- 7. Personal security

8. Tracking of devices transmitting unauthorized video, sound, or electronically stored data; as well as affiliated protective services

Association's governing is performed by a 5- members-board. The Board and other officers are democratically elected by the members every 2 years at the Annual General Meeting, usually on the 2nd weekend in October. A Mid-Term-Meeting is held alternatively to the AGM.
