WAD Chairman, ex-presidents and Europe area governor. The theme of the congress was the social commitment of the private detective and included subjects such as the intervention of the private detective in family legal proceedings, the search for missing persons, public-private collaboration and legal issues in professional matters. Panellists included police officers, judges, prosecutors and lawyers.

In 2024, APDPE will host its conference and AGM in March, in Valencia. APDPE was appointed as host of the IKD meeting in 2024.
